7. Old Business

- a. Academic Integrity Update on Implementation and Infographic Update
- Nadia Itani and William Clyde continue to work with the Office of Marketing and Communication on the distribution of the Academic Integrity Policy bookmark

b. Common Exam Scheduling

Carlos Tonche mentioned this is the third iteration of this policy re. common exams and having more than two exams on a given day. The policy is not finalized.

Some shared concerns:

- Common exam as the exam to be re-scheduled is problematic. Involves the most students.
- Do the times of the exam align with the course time in the semester?
- Exam schedules are with random arrangement from Registrar's office.
- Wording is not clear. should vs. must and 3 exams vs. 4 exams
- Should core exams stay constant always scheduled at the same time?
- Do students know what a common exam is?
- Is this intended for this semester Spring 2020? Yes...
- Is the scheduling done electronically yes, but the program is antiquated (1995)
- A fourth draft is expected but the third draft may be shared with faculty

c. Practice of weekday classes only having weekday exams

- A faculty member who has two sections cannot have a common exam. Can this be reconsidered for Saturday exams?
- Is there any School that objects to Saturday exams?
- A problem is related to the grade submission policy

d. Proposed change in Grade Replacement Policy

- Jake had some concerns but was not present at the meeting so the discussion may need to be on hold
- Grade replacement may not be used to replace a grade assigned as a result of academic dishonesty (e.g. as a consequence of a two-point or a second one-point violation that carried a sanction of an "F" for the course).
- e.g. should be i.e.
- This needs to be addressed at the next meeting
- e. Independent Studies Update
 - To be discussed at the next EAC meeting.
 - A draft has been started but will be moved to next meeting

8. New Business

- a. T-Grade Policy
 - Carlos Tonche explained what this is –
 - Graduate Council has approved this proposal
 - The voting will be held at next meeting to give EAC members an opportunity to discuss this with members of their School
